

Computer/Internet Acceptable Use Policy and Disclaimer

Computers are available for public use. The Harwinton Public Library will not assume responsibility for the accuracy, content, completeness or type of information found on the Internet. The Library does not monitor or control the content of material available through the Internet. Children under 18 years of age must have a permission form signed by a parent or guardian. Users under 12 years of age must be accompanied by an adult. Parents or guardians who wish to limit or restrict the access of their own children should personally oversee their use of the Internet and other forms of electronic information. Minors who visit the library without a parent or guardian are responsible for their own decisions and behaviors. Parents and legal guardians are responsible for any loss or damage incurred by minors.

Patrons may not use their own software on Library computers.

Users of Library computing resources must comply with federal and state laws, Library rules and policies, and terms of applicable contracts including software licenses while using said resources. Examples of applicable laws, rules and policies include laws of libel, privacy, copyright, trademark, obscenity and child pornography, the Electronic Communications Privacy Act and the Computer Fraud and Abuse Act, which prohibit “hacking”, “cracking”, and other similar activities. Users who engage in electronic communications with persons in other states or countries or on other systems or networks may also be subject to the laws of those jurisdictions and the rules and policies of those other systems and networks.

Patrons may not alter computer settings and/or configurations.

Patrons may not save any information to the “hard disk” (C:drive) of the computer.

When demand for computers exceeds the availability of a computer, a time limit may be imposed on use.

Patrons are responsible for damage or loss of a Library computer, or any part and/or accessory thereof (printers, CD Rom’s etc.), caused when they are using a computer and its accessories. The cost of repairs and replacements will be determined by the Library Director and charged to the responsible patron. Intentional and/or repeated misuse of computers will result in loss of computer privileges when deemed necessary by the Library Director.

A registration form must be completed by each user of the Internet.

All users must check/sign in at the desk and check/sign out when done.

Downloading from the Internet can only be done with patron’s storage device.

Patrons use their credit cards on the Internet at their own risk.

Inappropriate use or abuse of the Internet will result in loss of Internet privileges.

Using Wireless at the Harwinton Public Library

The Harwinton Public now offers free wireless Internet access to patrons with wireless-enabled laptop computers or handheld devices. By accessing our Wi-Fi, the patron has agreed to abide by the library’s Internet Computer Use Policy

Library staff cannot provide the wireless card, configure or troubleshoot your equipment. There is no guarantee that you will make your wireless connection.

All wireless access users should have up to date virus protection on their laptop computers or wireless devices.

The library will not be responsible for any information (eg. credit card numbers, social security numbers, passwords) that is compromised, or any damage that is caused to the hardware or software due to security issues or consequences caused by viruses or hacking.
